Q: What changes is Guardian making to its reimbursement practices?

A: As part of our commitment to going digital, reimbursement by EFT or Virtual Credit Card, will be our standard payments methods. If you elect reimbursement by non-standard methods, including by paper check, you may experience slower reimbursement times and may incur additional charges, in compliance with state law.

Q: How will I get paid for claims?

A: Guardian has partnered with Echo to offer EFT payments. To sign up, simply click [here](#) to access the Guardian-Echo enrollment page to complete and submit the EFT/ERA enrollment form. Q: Do I have to pay for EFT?

A: No. If you sign up for EFT for Guardian through Echo, there is no fee for the basic service.

Q: If there is an EFT overpayment, can funds be withdrawn from my EFT bank account?

A: No. EFT enables electronic deposits. If there is an overpayment issue, we will contact you to discuss the situation and repayment options.

Q: Will I still be able to access an EOB?

A: Yes. EOBs are available on Guardian Anytime for every claim processed allowing you to reconcile the EFT payment with ease. Additionally, EOBs will also be available on the Echo [provider portal](#).
